**OKLAHOMA HUMANE FEDERATION
MEMBERSHIP PROTOCOL**

Participation in Oklahoma Humane Federation is based on the principles of honesty, integrity, and mutual respect. Members of Oklahoma Humane Federation are expected to support the mission and purpose of OHF and adhere to the minimum standard of professional conduct as described in this protocol.

Individuals or organizations providing shelter shall not, under any circumstances, allow rescue animals to breed. Animals shall not be chained or maintained in temporary shelter such as carriers. Site visits by OHF board members may be required to confirm these housing standards for approval of membership, and may be requested by OHF colleagues from time to time.

Any individual or organization which makes dishonest claims, defrauds a potential adopter financially or otherwise, violates any terms of any contract concerning their organization, or violates the spirit or intent of the 1986 Dog and Cat Sterilization Act may be denied or removed from membership in OHF at the sole discretion of the Board of Directors.

Any individual or organization that is charged with or convicted of animal cruelty, neglect, or related charges, either towards rescue animals or animals in their home, or is involved in any other illegal activities, may be denied or removed from membership in OHF at the sole discretion of the Board of Directors.
